

**BY-LAW NO. 789  
OF THE  
TOWN OF STAVELY**

**A BYLAW OF THE TOWN OF STAVELY, IN THE PROVINCE OF ALBERTA, TO AMEND BY-LAW NO. 779, BEING THE MUNICIPALITY'S WATER & SEWER BYLAW.**

**WHEREAS** Section 7 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000, authorizes a Council to pass bylaws;

**NOW THEREFORE**, the Council of the Town of Stavely, in the Province of Alberta, duly assembled, enacts as follows:

This bylaw hereby amends the Water & Sewer Bylaw # 779, by revising Schedule "A" as reflected in this Schedule "A", attached hereto and forming part of this Bylaw, and Schedule "B" of Bylaw No. 779, as reflected in this Schedule "B", attached hereto and forming part of this Bylaw.

This Bylaw will be cited as the Amendment to Water and Sewer Bylaw No. 789.

Bylaw No. 779 is hereby amended.

This Bylaw will come into force and effect on January 1, 2016.

READ a first time this 23 day of November, 2015.

READ a second time this 23 day of November, 2015.

8.2	Application fee for permission to use a private well.	\$50
11.2	Monthly charge for residential water consumers	\$31 up to 27 cubic meters, over 27 cubic meters 1.50 per cubic meter.
11.2	Monthly charge for non-residential water consumers	\$38 up to 90 cubic meters, over 90 cubic meters 0.50 per cubic meter.
11.2	Monthly charge for school water consumers	\$112 up to 45 cubic meters, over 45 cubic meters 0.33 per cubic meter.
11.2	Monthly charge for the Oxley Manor	\$24.50 plus \$24.50 per occupied suite.
