#### Foreman Watson-

1)Update of summer projects that are ongoing: New hydrant replacement will most likely be completed in the fall. Not sure yet how this will work with sidewalk replacement in Young and Park Cres. areas. We are collecting quotes on installation of new water fill station, and we are close to finalizing the location in the public works yard. Wednesday's could potentially be a busy traffic day if people are using the sani dump, or water fill station, or rural garbage drop off. We feel we should be able to make that work. Possible additional signage may be needed.

- 2) Clay Moss has completed his operator requirements for small water and wastewater systems. So next is Level 1 with water treatment & distribution. Also wastewater treatment & collection. He should be able to complete those requirements within the next 6 to 8 months. Stavely is a level 1 water/wastewater facility.
- 3) Maintenance: The 1999 F 450 garbage is having serious transmission problems. Nobody in Claresholm would be willing to work on this size of truck. Next option is Fort Macleod or Lethbridge. How much or any work would we want to do on this unit?

#### BYLAW #866-LAND USE AMENDMENT:

Lot 3, Block 2 Plan 7411106;

WHEREAS shown on Schedule 'A' attached hereto, from "Residential - R" to "Residential Multi-unit - R2";

WHEREAS the Council has determined that the "Residential Multi-unit – R2" designation is appropriate for the lands;

AND WHEREAS the purpose of the proposed amendment is to allow a manufactured home development;

**THEREFORE** under the authority and subject to the provisions of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended, the Council duly assembled does hereby enact the following:

- 1. This bylaw shall be cited as "Land Use Bylaw Amendment No. 866".
- 2. Amendment to Land Use Bylaw No. 769 as per "Schedule A" attached.
- 3. This bylaw shall come into force and effect upon third and final passing thereof.
- 4. That Bylaw No.866 be consolidated to Bylaw No.769.
